## About us

Fitzroy Partnership for River Health was formed in 2012 and includes a unique membership of government, industry, research and community stakeholders, who all have an interest in the health of waterways across the Fitzroy Basin. The Partnership's role is to facilitate improved water quality monitoring, collate and assess data collected by organisations across the basin, and develop public report cards on waterway health to provide community assurance and certainty. Our dedicated Independent Science Panel works alongside the Partnership to assess data and results to ensure annual report cards are independent, and accurately reflect condition and trends of waterways in the Fitzroy Basin. In 2021, the Partnership reaches a significant milestone releasing its 10th Fitzroy Basin Report Card providing a decade of data, trends and cementing its position as Queensland's leading regional report card collective.

Our Partnership Network, of which every partner is a member, meets regularly to affirm their commitment to waterway health and guide our vision of 'healthy waterways in the Fitzroy Basin through trusted information'. The small Partnership team also works to promote waterway health and encourage citizen science in action to increase awareness about the balance between a busy, working Basin with a growing regional population and waterway health in the largest Australian catchment leading to the World Heritage Protected Great Barrier Reef lagoon.
