As we reflect on the 2024–2025 financial year, I am once again proud to acknowledge the ongoing strength and resilience of the Fitzroy Partnership for River Health. This year has brought with it a number of changes within our team, and I commend the Partnership for maintaining its momentum, professionalism, and focus on delivering credible, independent reporting on the health of our waterways. Despite this period of transition, the team has upheld the vision and reputation of the Partnership — an achievement that speaks volumes about their dedication and adaptability.

The Partnership's work in engaging our community has continued to flourish, with 26 community, school and citizen science events and activities delivered, educating more than 2,500 people about waterway health. This ongoing outreach and education are essential in building awareness and inspiring stewardship across the Fitzroy Basin. I am particularly pleased to see the growth in our citizen science and human dimensions programs, which highlight how shared knowledge and community involvement are central to sustainable water management.

Financially, the Partnership remains in a stable and responsible position, recording an income of \$905,313 and a modest surplus of \$4,220 for the 2024–2025 financial year. This demonstrates continued prudence in managing resources while ensuring our programs and partnerships deliver value across the region.

As Chair, I am immensely proud of how our partners, staff, and broader community continue to work together in pursuit of our shared goal: a healthy, resilient Fitzroy Basin. The challenges faced this year have only reinforced the strength of our collaborative model and the importance of the work we do.

Reef 2050 Long-Term Sustainability Plan

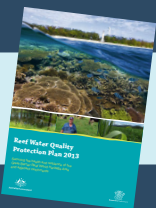
Our work aligns with Water Quality Action 23, to expand integrated water quality monitoring and report card programs in the Fitzroy Basin priority catchment.



Reef Water Quality Protection Plan 2013

Our report card is aligned to the GBR report card and utilises relevant data from monitoring programs within the Region.

Our reporting meets the requirements of the Queensland State of the Environment Indicators to measure the following six overarching Sustainable Development Goal (SDG) targets: good health and wellbeing, clean water and sanitation, responsible consumption and protection, life below water, life on land and partnerships for the goals.



Water Quality Improvement Plan

The Partnership utilises the environmental condition information from the WQIP to ensure consistency for management priorities, environmental values and ecologically relevant targets.



We align our monitoring, management and research strategies with CQSS2030 – Fitzroy Basin Association's Central Queensland Sustainability Strategy 2030 to provide a joint strategic direction for ongoing planning, practice and change.



We work closely with similar monitoring and reporting initiatives in South-East Queensland, Mackay, Gladstone, Townsville and the Wet Tropics.
